Chapter 2 - ANIMAL IMPORTATION REGULATIONS

<u>001</u> Statement of Purpose. The purpose of these regulations is to aid in administering the Animal Importation Act, <u>Neb</u>. <u>Rev</u>. <u>Stat</u>. §§54-784.01 to 54-796, and other acts under the department's jurisdiction, and in the C.F.R. <u>Title 9 of the Code of Federal Regulations</u> sections adopted by reference related to the importation of <u>livestock</u> <u>animals</u>. <u>Copies of all items listed in the Appendix, 015 Publications Adopted, are attached and are on file and available for viewing at the office of the Nebraska Department of Agriculture, located in the State Office Building, Fourth Floor, 301 Centennial Mall South, Lincoln, Nebraska, and at the office of the Secretary of State, Division of Rules and Regulations, Room 1305 of the Nebraska State Capitol,1445 K Street, Lincoln, Nebraska.</u>

<u>002 Definitions</u>. The definition of terms found in the Animal Importation Act, and other laws, and regulations under the department's jurisdiction and in those sections of the 9 C.F.R. sections Parts 1 to 199 (2012), adopted and incorporated herein adopted by reference related to the importation of livestock animals shall apply to such terms when found in these regulations, except where inconsistent, in which case definitions in the Animal Importation Act and these regulations control. The terms and their definitions set out in this section shall have the same meaning throughout these regulations.

002.01 ACCREDITATION PREPARATORY STATE or ZONE means a state or zone that complies with the provisions of "Uniform Methods and Rules - Bovine Tuberculosis Eradication" the Bovine Tuberculosis Eradication, Uniform Methods and Rules, (2005), (Bovine TB UM&R) a copy of which is attached as Appendix A, and is adopted and incorporated herein by reference, and in which tuberculosis (TB) is prevalent in less than one-half of one percent (0.5%) 0.5 percent of cattle herds in the state.

- <u>002.02</u> ACCREDITED FREE STATE or ZONE means a state or zone that has zero percent (0%) herd prevalence of tuberculosis <u>TB</u> affected cattle herds, or one (1) infected herd during the previous twelve (12) months, and complies with the provisions of the Bovine <u>TB UM&R</u>. "Uniform Methods and Rules Bovine Tuberculosis Eradication."
- 002.03 ACCREDITED HERD means a herd that has passed at least two (2) consecutive official tuberculin tests of all eligible animals conducted at 9 to 15 month intervals, has no evidence of, or exposure potential to, bovine tuberculosis and meets the standards of the Bovine TB UM&R. Pursuant to 9 C.F.R. §77.5, all cattle and bison in a herd must be free from TB for purposes of maintaining accredited herd status.
- <u>002.04</u> <u>002.03</u> ACCREDITED VETERINARIAN means a veterinarian approved by the Animal and Plant Health Inspection Service (APHIS) of the United States Department of Agriculture (USDA) APHIS in accordance with 9 C.F.R. subchapter J, Parts 160 to 162 (2003).
- <u>002.05</u> <u>002.04</u> ADMINISTRATOR means the Administrator of the Animal and Plant Health Inspection Service of the United States Department of Agriculture (APHIS), or any person authorized to act for the Administrator.
- 002.06 002.05 ANIMAL means (1) all vertebrate members of the animal kingdom, except humans, fish, amphibians, and reptiles, Neb. Rev. Stat. §54-786(1):; (2) For for the purposes of Chronic Wasting Disease (CWD) ANIMAL means any captive cervid.
- 002.07 002.06 APHIS means the Animal and Plant Health Inspection Service of the USDA.
- <u>002.07</u> APPROVED EARTAG means an identification tag approved by APHIS or the Bureau which shall be placed in the ear to identify individual animals.
- <u>002.08</u> APPROVED LIVESTOCK FACILITY means premises where <u>cattle</u> livestock are assembled for sale or sale purposes which meet the standards set forth in 9 C.F.R. §71.1 (2003) and is approved under §71.20.
- 002.09 ASSEMBLED GROUP means, for purposes of TB testing only, cattle from more than one original premises which have been brought together as a herd, typically by a broker or dealer, for resale.
- <u>002.09</u> BUREAU means the Bureau of Animal Industry of the Nebraska Department of Agriculture and shall include: (1) state veterinarian, deputy state veterinarian, animal epidemiologist, and any other veterinarians, livestock inspectors, investigators, and other employees all of whom are employed by the Bureau; and (2) veterinarians, animal health technicians, and investigators employed by APHIS and performing duties delegated to them by the Bureau.

- <u>002.10</u> CATTLE means all <u>domestic bovine animals of all ages, including beef cattle, dairy cattle, and bison, except where otherwise noted herein dairy cattle, beef cattle, and bison.</u>
- 002.11 CERTIFICATE OF VETERINARY INSPECTION or HEALTH CERTIFICATE means a legible record issued by an accredited veterinarian in accordance with the requirements of the state or country of destination, and recorded on an official form of the state of origin or an approved USDA form. CERTIFICATE OF VETERINARY INSPECTION (CVI) means a legible document, either paper copy or electronic, issued by an accredited veterinarian at the point of origin of an animal movement, which meets the requirements in subsection 004.03 of these regulations, an example of which is attached as Appendix B, and is adopted and incorporated herein by reference.
- <u>002.12</u> CERVIDAE or CERVID means any elk, deer, or other member of the family cervidae legally obtained from a facility which has a license, permit, or registration authorizing domesticated cervine animals, which has been issued by the state where the facility is located, and such animal is raised in a confined area.
- <u>002.13</u> CERVID HUNT PASTURE means a facility occupied by a cervid herd consisting entirely of animals of the same sex that is maintained for hunting purposes.
- 002.14 CLASS FREE; AND CLASS A, CLASS B, and CLASS C STATE OR AREA means a brucellosis classification of a state or area so classified by APHIS as provided in 9 C.F.R. §78.1 (2003)., and in the Brucellosis Eradication: Uniform Methods and Rules, Effective October 1, 2003 (Brucellosis UM&R), a copy of which is attached as Appendix C, and is adopted and incorporated herein by reference.
- 002.15 CODE OF FEDERAL REGULATIONS (C.F.R.) means a codification of the general and permanent rules published in the *Federal Register* by the executive departments and agencies of the Federal Government revised as of January 1, 2003 2012, copies of relevant parts, sections, and subsections of Title 9, Code of Federal Regulations §§ 54, 55, 71, 75, 77, 78, 79, 85, 93.400, 93.417, 93.418, 93.420, 93.424 to 93.427, 93.429, 145, 146, 147, 160, 161 and 162 are attached in Appendix D, and which are adopted and incorporated herein by reference and are hereby adopted and promulgated and are available for viewing at the Nebraska Department of Agriculture, 301 Centennial Mall South, Fourth Floor, Lincoln, Nebraska 68509-4947.
- <u>002.16</u> CONCENTRATION POINT means any facility where livestock from two <u>(2)</u> or more herds are assembled and subsequently dispersed to one (1) or more locations.
- <u>002.17</u> CWD-ENDEMIC AREA means a county and any portion of the surrounding area, as designated by the Department, USDA, or another state's regulatory agency, where a wild cervid animal has been diagnosed with Chronic Wasting Disease (CWD).
- <u>002.18</u> CWD-EXPOSED ANIMAL means an animal that is part of a CWD-positive herd, or that was part of a herd within five (5) years sixty (60) months prior to that herd's

- designation as CWD positive, or an animal that has been housed with or been in direct contact with a positive animal, or an animal that has been on a contaminated premises.
- 002.19 CWD-EXPOSED HERD means a herd in which a Chronic Wasting Disease (CWD)-positive or exposed animal has resided 60 at any time during the sixty (60) months prior to the diagnosis of CWD.
- <u>002.20</u> CWD-POSITIVE ANIMAL means an animal that has had a diagnosis of CWD confirmed by means of an two (2) official CWD test tests as defined in 9 C.F.R. §55.1.
- <u>002.21</u> CWD-POSITIVE HERD means a herd in which a CWD positive animal resided at the time it was diagnosed and which has not been released from quarantine.
- $\underline{002.22}$ CWD-TRACE HERD means: $\underline{4}$) $\underline{(1)}$ a herd in which a CWD-positive animal resided in any of the $\underline{\text{sixty }}$ $\underline{60}$ ($\underline{60}$) months prior to diagnosis; or $\underline{2}$) ($\underline{2}$) a herd that received exposed animals from a positive herd within $\underline{\text{sixty }}$ $\underline{60}$ ($\underline{60}$) months prior to the diagnosis of CWD in the positive herd.
- 002.23 DEPARTMENT means the Nebraska Department of Agriculture or its authorized agent-, and shall include: (1) state veterinarian, deputy state veterinarian, animal epidemiologist, and any other veterinarians, livestock inspectors, investigators, and other employees all of whom are employed by the Department; and (2) veterinarians, animal health technicians, and investigators employed by USDA/APHIS/VS when performing duties delegated to them by the Nebraska Department of Agriculture.
- 002.24 DEPARTMENT ACCEPTED EARTAG means an eartag that bears a unique identification number for each individual animal and the unique identification number on such eartag shall be recorded in a manner which allows the animal to be traced to the location where the tag was applied to the animal. Such eartag shall be tamper resistant and have a high-retention rate in the animal.
- <u>002.25</u> <u>002.24</u> DESTINATION means a location designated on a Certificate of Veterinary Inspection CVI where the animals imported will be unloaded at the final shipping point.
- 002.26 002.25 DIRECT TO SLAUGHTER means delivered directly to a federally recognized slaughter establishment, as such establishment is defined in 9 C.F.R. §78.1.
- <u>002.27</u> <u>002.26</u> EXOTIC ANIMAL means any animal whose species is not now, or was not historically, indigenous to the State of Nebraska.
- <u>002.28</u> <u>002.27</u> EXPOSED ANIMAL means any animal that has had contact with an affected herd or infected animal such that transmission of an infective <u>disease</u> agent may have occurred.
- <u>002.29</u> <u>002.28</u> FEEDING means the conditioning or fattening of animals in a confinement which does not contain growing grass or herbage for nutritional purposes.

- 002.30 FEMALE means any sexually intact animal of the female gender.
- 002.31 002.29 GRAZING means to feed on growing grass or herbage.
- <u>002.32</u> <u>002.30</u> HERD means (1) any group of animals maintained on common ground for any purpose; or (2) two or more groups of animals under common ownership or supervision, geographically separated but which have an interchange of animals without regard to whether the animals are infected or exposed.
- 002.31 HERD BLOOD TEST means a test as so defined in 9 C.F.R. §78.1 (2003).
- <u>002.32</u> IMPORT QUARANTINE means a restriction placed on animals by the issuance of a document by the Bureau. The quarantine shall restrict the movement of specific animals located in Nebraska or entering Nebraska. The document shall (1) list the animals restricted, (2) the reason for the restriction, (3) the conditions of the restriction, and (4) the conditions to be met to release the restrictions.
- 002.33 IMPORTED FOR BREEDING PURPOSES means sexually intact cattle imported into Nebraska for reproductive purposes, including all processes from breeding through weaning.
- 002.34 IMPORTED FOR FEEDING PURPOSES means cattle imported into Nebraska moving direct to slaughter, or to a feedlot and then to slaughter, and not diverted for breeding or exhibition.
- 002.35 INDIVIDUAL IDENTIFICATION means a unique number which is assigned to an animal for purposes of interstate movement, disease control, or both. Individual identification may be: (a) a Department accepted eartag as defined herein; (b) a radio frequency identification device; (c) a legible breed registry tattoo; or (d) a registered herd hot brand in combination with a unique, legible freeze brand which identifies a specific animal within the herd.
- <u>002.36</u> KNOWN NEGATIVE *Tritrichomonas foetus* (*T. foetus*) MALES means breeding males which have been found negative for *T. foetus* in compliance with the testing protocol in accordance with part 005.04A of these regulations.
- 002.37 MALE means any sexually intact animal of the male gender.
- <u>002.38</u> <u>002.33</u> MARKET means a livestock auction market as defined in the Livestock Auction Act and livestock market as defined in the Nebraska Livestock <u>Auction Market Act and approved under 9 C.F.R. §71.20 (2003).</u>
- <u>002.39</u> <u>002.34</u> MODIFIED ACCREDITED ADVANCED STATE or ZONE means a state or zone that complies with the provisions of <u>Bovine TB UM&R</u> "Uniform Methods and Rules Bovine Tuberculosis Eradication" and in which tuberculosis is prevalent in less than one-tenth of one percent (0.1%) <u>0.01 percent</u> of cattle herds in the state or 1-3 infected herds in states with fewer than 30,000 herds.

- <u>002.40</u> <u>002.35</u> MODIFIED ACCREDITED STATE or ZONE means a state or zone that complies with the provisions of <u>the Bovine TB UM&R</u> <u>"Uniform Methods and Rules Bovine Tuberculosis Eradication"</u> for the past twelve (12) months and in which TB is prevalent in less than one-tenth of one percent (0.1%) <u>0.1 percent</u> of cattle herds in the state or a maximum of ten (10) infected herds in states with fewer than 10,000 herds.
- 002.41 NEUTERED means any sexually altered animal.
- <u>002.42</u> <u>002.36</u> <u>NON-ACCREDITED</u> <u>NONACCREDITED</u> STATE or ZONE means a state or zone that does not meet the minimum standards of <u>the Bovine TB UM&R</u> "<u>Uniform Methods and Rules Bovine Tuberculosis Eradication"</u> or in which TB is prevalent in one-half of one percent (0.5%) <u>0.5 percent</u> or more of the total number of herds of cattle in the state.
- <u>002.43</u> <u>002.37</u> NON-INDIGENOUS CERVID ANIMALS means any cervine animal whose species is not native to Nebraska and shall include, but not be limited to sika deer, fallow deer, reindeer and Pére David's deer.
- <u>002.44</u> <u>002.38</u> OFFICIAL BRUCELLOSIS TEST means, for purposes of these regulations only, an official test for brucellosis as provided in 9 C.F.R. §78.1 (2003).
- 002.39 OFFICIAL CALFHOOD VACCINATE (OCV) means a female bovine or bison which has been vaccinated with an approved *Brucella abortus* vaccine between four (4) months and twelve (12) months of age and identified as provided in 9 C.F.R. §78.1 (2003).
- <u>002.40</u> OFFICIAL EARTAG means an APHIS approved identification eartag conforming to the nine-character alpha-numeric National Uniform Eartagging System which provides unique identification for each animal.
- <u>002.45</u> <u>002.41</u> OFFICIAL GENOTYPE TEST means any test to determine the genotype of a live or dead animal that is conducted at either an approved laboratory or at the National Veterinary Services Laboratory when the animal is officially identified and the samples used for the test are collected and shipped to the laboratory by either an accredited veterinarian or a Department or APHIS representative.
- <u>002.42</u> OFFICIAL IDENTIFICATION means (1) individual identification with an official eartag or a breed registration tattoo or other identification approved by the Department, which is affixed to an animal and provides identification of such animal, or (2) a premises identification number (tattoo or tag) assigned by APHIS.
- <u>002.43</u> OFFICIAL PSEUDORABIES TEST means an official test for pseudorabies as provided in 9 C.F.R. §85.1 (2003).
- 002.46 002.44 OFFICIAL TUBERCULIN TEST means, for purposes of these regulations only, an official test for tuberculosis TB as provided in 9 C.F.R. §77.1 (2003).

<u>002.45</u> OFFICIAL USDA MARKET BACKTAG means a backtag issued by APHIS for identifying livestock moving in commerce.

<u>002.46</u> OWNER-SHIPPER STATEMENT means a statement signed by the owner or shipper of swine which states: (1) the number of swine to be moved; (2) the purpose for which the swine are to be moved; (3) the points of origin and destination; and (4) the consignor and the consignee, a copy of which is attached and incorporated herein by reference and is hereby adopted and promulgated.

002.47 PERMANENT INDIVIDUAL IDENTIFICATION (domesticated cervine only) means (1) a USDA approved silver, metal eartag which has a nine-character alpha-numeric identification; or (2) an ear tattoo which is legible and provides a unique number that can identify an individual animal. New tattoos applied in Nebraska shall have the state code "NE" followed by the domesticated cervine animal herd number in the right ear, along with a unique four (4) digit number on each animal that may be applied to either ear. All tattoos shall be at least three-eighths (3/8) inch high; or (3) a form of tamper-proof eartag, approved by the Department, which includes the domesticated cervine animal herd number and a unique animal number; or (4) an electronic identification device eartag, or (5) a radio frequency identification device (RFID).

<u>002.48</u> PERMIT FOR ENTRY or <u>IMPORT</u> PERMIT means a pre-movement authorization for entry into the State of Nebraska obtained from the <u>Bureau Department</u>, an example of which is attached as Appendix E and is adopted and incorporated herein <u>by reference</u>. This authorization shall state the conditions under which the movement may be made. The permit number shall be recorded on the <u>Certificate of Veterinary Inspection</u> CVI.

<u>oo2.49</u> PSEUDORABIES PROGRAM STANDARDS means, for purposes of these regulations, those standards set forth in the <u>Pseudorabies Eradication</u>, State-Federal-Industry Program Standards for <u>Pseudorabies Eradication</u>, dated , <u>Effective November 1, 2003 January 1, 2000</u>, as approved by the Veterinary Services Division of the Animal and Plant Health Inspection Services (APHIS), an agency of the United States Department of Agriculture <u>USDA/APHIS/VS</u>, a copy of which is attached <u>as Appendix F, and is adopted</u> and incorporated herein by reference and is hereby adopted and promulgated.

<u>002.50</u> QUALIFIED PSEUDORABIES NEGATIVE HERD, QUALIFIED PSEUDORABIES NEGATIVE GROWOUT HERD, AND PSEUDORABIES MONITORED FEEDER-PIG HERD means such herd as provided for in the Pseudorabies Program Standards.

<u>002.51</u> QUARANTINE FACILITY means any enclosure sufficient to prevent animals from coming into physical contact with any other animals or their body excrements.

002.52 RANDOM SAMPLE TEST (95/10) means a sampling procedure utilizing an official pseudorabies serologic test which provides a ninety-five percent (95%) probability of detecting infection in a herd in which at least ten percent (10%) of the

swine are seropositive for pseudorabies. Each segregated group of swine on an individual premises shall be considered a separate herd and sampled by testing all up to thirty (30) head.

QUARANTINE means a movement restriction placed on an animal or animals issued by the Department. The quarantine is a written document outlining the restriction of movement for a specific animal, animals, or herd of animals located in Nebraska or entering Nebraska. The quarantine document shall list: (1) the animals restricted; (2) the reason for the restriction; (3) the conditions of the restriction; and (4) the location of the quarantined animal or animals. Any animal, animals, or herd of animals placed under quarantine shall remain quarantined to the specified location until such quarantine is released by the Department.

002.51 RADIO FREQUENCY IDENTIFICATION DEVICE (RFID) means an electronic tag or device approved for use by APHIS or the Department as individual animal identification.

002.52 002.53 RATITE BIRD means any ostrich, emu, rhea, kiwi, or cassowary.

002.53 RODEO CATTLE means cattle used or intended to be used for, or have previously been used for, but not limited to, rodeos and timed events.

O02.54 SCRAPIE ERADICATION PROGRAM means the cooperative state-federal program administered by USDA/APHIS/VS and States to control and eradicate scrapie. For purposes of interstate movement only, official identification and testing requirements may be found in 9 C.F.R. part 79 and Scrapie Eradication, Uniform Methods and Rules (Scrapie Eradication UM&R), June 1, 2005, copies of which are attached as Appendix G, and adopted and incorporated herein by reference.

002.55 002.54 SCRAPIE HIGH-RISK ANIMAL means a sexually intact animal that is: (1) the progeny of a scrapie-positive dam; or (2) born in the same flock during the same lambing season as progeny of a scrapie-positive dam, unless the progeny of the scrapie-positive dam are from separate contemporary lambing groups; or (3) born in the same flock during the same lambing season that a scrapie-positive animal was born, or during any subsequent lambing season, if born before the flock completes the requirements of a flock plan; or (4) an exposed female sheep determined to be genetically susceptible or of an unknown genotype.

002.56 002.55 SCRAPIE INFECTED FLOCK means any flock in which a State the Department or APHIS representative has determined that a scrapie-positive female has resided unless an epidemiologic investigation conducted by a designated scrapie epidemiologist shows that the animal did not lamb or abort while in the flock. A flock will no longer be considered an infected flock after it has completed the requirements of a flock plan.

<u>002.57</u> <u>002.56</u> SCRAPIE POSITIVE ANIMAL means an animal for which a diagnosis of scrapie has been made by an approved laboratory through one of the following: (1) Histopathological examination of the central nervous system (CNS) tissues from the

animal for characteristic microscopic lesions of of scrapie; (2) The use of proteinase-resistant protein analysis methods including but not limited to immunohistochemistry or western blotting on CNS or peripheral tissue samples from a live or dead animal for which a given method has been approved by the Administrator for use on that tissue; (3) Bioassay; (4) Scrapie associated fibrils detected by electron microscopy; or (5) Any other test method approved by the Administrator in accordance with 9 C.F.R. § 54.10.

002.58 002.57 SCRAPIE SOURCE FLOCK means a flock in which a Department or APHIS representative has determined that at least one animal was born that was diagnosed as a scrapie-positive animal at an age of seventy-two (72) months or less. The determination that an animal was born in a source flock shall be in accordance with the guidelines in 9 C.F.R. parts 54 and 79. A flock will no longer be a source flock after the requirements of a flock plan, as defined in §54-2719 of the Scrapie Control and Eradication Act, have been completed.

<u>002.59</u> <u>002.58</u> SCRAPIE SUSPECT ANIMAL means (1) a sheep or goat that exhibits any of the following possible signs of scrapie and that has been determined to be suspicious for scrapie by an accredited veterinarian, or <u>al department the Department</u> or APHIS representative. Possible signs include: weight loss despite retention of appetite; behavioral abnormalities; itching; wool pulling; biting at legs or side; lip smacking; motor abnormalities such as incoordination, high stepping gait of forelimbs, bunny hop movement of rear legs, or swaying of back end; increased sensitivity to noise and sudden movement; or tremor, star gazing, head pressing, recumbency, or other signs of neurological disease or chronic wasting; (2) A sheep or goat that has tested positive for scrapie or for the proteinase resistant protein associated with scrapie on a live-animal screening test or any other official test, unless the animal is designated a scrapie-positive animal; and (3) A sheep or goat that has tested inconclusive or suggestive on an official test for scrapie.

<u>002.60</u> <u>SLAUGHTER CHANNELS means movement of an animal into Nebraska to be sold, transferred, or moved: (a) direct to slaughter; or (b) to a feedlot and then to slaughter.</u>

<u>002.61</u> <u>002.59</u> STAGE shall refer to the designation I, II, III, IV, and V assigned to a state or area of a state by APHIS with respect to the level of pseudorabies as defined in Part III of the Pseudorabies Program Standards.

002.62 002.60 TEST-ELIGIBLE CATTLE means: (1) for purposes of brucellosis testing, six (6) months of age and older; (2) for purposes of trichomoniasis testing, all sexually intact, non-virgin males of any age; and all males twenty-four (24) months of age and older; and (3) for purposes of TB testing, two (2) months of age and older. all cattle over eighteen (18) months of age (as evidenced by the loss of the middle pair of temporary incisor teeth) except steers, spayed heifers, official calfhood vaccinates of the dairy breeds under twenty (20) months of age, and official calfhood vaccinates of the beef breeds and bison under twenty-four (24) months of age (as evidenced by the presence of the middle pair of permanent incisor teeth) which are not parturient or post-parturient.

- <u>002.63</u> <u>UNIFORM METHODS AND RULES (UM&R) means the minimum standards approved by the USDA/APHIS/VS for the detection, control, prevention, and eradication of specific livestock diseases.</u>
- 002.64 002.61 USDA means the United States Department of Agriculture.
- <u>002.65</u> <u>USDA/APHIS/VS means the United States Department of Agriculture (USDA),</u> Animal and Plant Health Inspection Service (APHIS), Veterinary Services (VS).
- <u>002.66</u> <u>VETERINARY SERVICES (VS) means the animal health division of the United</u> States Department of Agriculture, Animal and Plant Health Inspection Service.
- <u>002.67</u> <u>VIRGIN means any sexually intact animal which has not been exposed to breeding activity.</u>
- 002.68 002.62 VISIBLE INDIVIDUAL IDENTIFICATION (domesticated cervine only) means identification that is used to differentiate a domesticated cervine animal from a wild cervine animal and shall consist of a plastic eartag that is at least one and three-fourths inches by one and three-fourths inches (1 3/4" x 1 3/4") in size, and shall be of a color that is clearly distinguishable from the animal on which it is placed.
- 002.69 002.63 VS FORM 1-27 means a USDA/APHIS/VS Permit for Movement of Restricted Animals form which, when properly completed, is a permit authorizing the movement of diseased or exposed animals, which and shall be issued only by an accredited veterinarian or authorized regulatory personnel, a copy of which is attached as Appendix H, and is adopted and incorporated herein by reference and is hereby adopted and promulgated.
- <u>002.70</u> <u>002.64</u> WILD PIG means all wild species in the family Suidae, including any Suidae exhibiting the morphological or behavioral characteristics of a wild pig, whether raised in captivity or not, including European wild boar.
- <u>003</u> Administration. These regulations shall be administered by the Department of Agriculture's Bureau of Animal Industry, Department of Agriculture located in the State Office Building, Fourth Floor, 301 Centennial Mall South, Lincoln, Nebraska. The mailing address is P.O. Box 94787, Lincoln, Nebraska 68509-4787. The telephone number is (402) 471-2351. The fax number is (402) 471-6893.
- 004 Importation of Animals in General.
 - <u>004.01</u> No animal infected with, exposed to, or suspected of having been exposed to any infectious, contagious, or otherwise transmissible disease, or originates from a quarantined area, herd, or flock, shall be transported into the state, except those animals consigned to direct slaughter and accompanied by a VS Form 1-27 or Owner-Shipper Statement, and except those animals specifically allowed entry by a permit issued by the Bureau Department under Neb. Rev. Stat. §54-787.

<u>004.02</u> Except as otherwise provided in this section, all animals brought into the state shall be accompanied by a complete and legible Certificate of Veterinary Inspection CVI. Animals not required to be accompanied by a Certificate CVI are: (a) animals brought directly to a federally recognized slaughter establishment, (b) cattle, swine, horses, sheep, and goats brought from the farm or ranch of origin directly to an establishment approved under 9 C.F.R. part parts 71, 75, 78, 79, or 85; (c) poultry under eight (8) weeks of age accompanied by a VS Form 9-3, "Report of Sales of Hatching Eggs, Chicks, and Poults", which is attached as Appendix I and is adopted and incorporated herein by reference, and classified prior to movement into Nebraska as pullorum and typhoid clean or equivalent status pursuant to the National Poultry Improvement Plan (NPIP), 9 C.F.R. parts 145 to 147 (2003), which are attached as Appendix D incorporated herein by reference and is hereby adopted and promulgated; and (d) animals moving directly to a veterinary clinic for diagnosis, treatment, or health examination.

004.03 The Certificate of Veterinary Inspection CVI shall be signed by an accredited veterinarian who acknowledges the apparent absence of any infectious, contagious, or otherwise transmissible disease. If a permit for entry is required for movement into the state, the permit number shall be recorded on the CVI. The CVI shall be valid for thirty (30) days from the date of examination, unless otherwise stated by the Department, and is valid for no more than one (1) movement into the state, with one (1) copy accompanying the animals to their Nebraska destination, and one (1) copy forwarded to the state of origin. The certificate shall contain the name and address of both consignor and consignee, the purpose of movement into the state, age, breed, sex, number of animals, the destination in the state, the description of the animals, and the identification and specific disease information for each species as prescribed in 23 NAC 2-005 to 014, below. If a permit for entry is required for movement into the state, the permit number shall be listed on the Certificate of Veterinary Inspection. Each Certificate of Veterinary Inspection shall be valid for thirty (30) days from date of examination, unless otherwise stated by the Bureau, and no more than one (1) movement into the state. NPIP (National Poultry Improvement Plan) VS FORM 9-3, a copy of which is attached and incorporated herein by reference and is hereby adopted and promulgated, may be used as a Certificate of Veterinary Inspection CVI for poultry under eight (8) weeks of age. A copy shall accompany the animal(s) animals and a copy shall be forwarded to the state of origin. Each CVI shall contain the following information:

004.03A Name and address of both consignor and consignee:

004.03B Purpose of movement into the state;

<u>004.03C</u> Destination in the state which includes the physical street address, or Enhanced 911 address of the premises;

004.03D Age, breed, sex, and number of animals in the shipment;

004.03E Description of the animals;

- <u>004.03F</u> <u>Individual identification, where otherwise required herein;</u>
- 004.03G Disease-specific importation requirements as prescribed in §§005 to 014, herein; or as prescribed in importation embargoes or orders; and
- 004.03H Health examination date of the imported animals.
- <u>004.04</u> Animals entering the state without the proper documents, when required by these regulations, may be <u>held in quarantine quarantined</u> at the expense of the owner until released by the <u>Bureau Department</u> or may be immediately returned to the state of origin, and a citation may be issued.
- <u>004.05</u> No animal or shipment shall be diverted from the Nebraska destination stated on the Certificate of Veterinary Inspection <u>CVI</u>, or similar document, except by <u>a</u> permit issued by the Bureau Department.
- <u>004.06</u> All blood samples required for testing animals for movement into the state shall be drawn by or under the supervision of an accredited veterinarian and the tests shall be conducted by a state-federal laboratory or a laboratory approved by the state of origin prior to shipment.
- <u>004.07</u> Requests for permits for entry, when required by these regulations, shall be made to the <u>Bureau Department</u>, telephone number <u>at</u> (402) 471-2351, which <u>The</u> permit number shall be recorded on the <u>Certificate of Veterinary Inspection CVI</u>, and <u>such permit</u> shall be valid for one (1) shipment only.
- <u>004.08</u> Whenever circumstances require an exception to these regulations, such exception may be granted by the <u>Bureau Department</u>. The exceptions shall be granted only when it is in the best interest of the livestock industry of Nebraska and when it is consistent with sound animal health practices. Applications for an exception shall <u>be in writing, and</u> completely and accurately describe the need for the exception. Exceptions granted shall be in writing although applicants may be advised in advance by telephone or in person that an exception has been granted.
- <u>004.09</u> All animals entering the state shall <u>be in compliance with federal interstate</u> movement requirements except when such requirements are inconsistent with these <u>regulations</u> meet all federal regulations concerning the interstate movement of such animals.
- <u>004.10</u> Animals entering the state which are subject to post-entry import requirements shall be restricted <u>by quarantine</u> to the location listed on the permit for entry and <u>Certificate of Veterinary Inspection CVI</u> until released by the <u>Bureau Department</u>. Any post-entry testing required to release <u>an import a</u> quarantine shall be done at owner expense.
- <u>004.11</u> The <u>Bureau Department</u> may issue greater restrictions should disease conditions warrant. These greater restrictions will be in the form of orders <u>or embargoes</u> issued on a case by case basis as new disease concerns arise.

004.12 <u>Vesicular Stomatitis</u>. <u>In addition to those general requirements contained in this section, all importers of cattle, camelids (including camels, llamas, alpaca, etc.), cervidae, equidae (including horses, donkeys, mules, etc.), sheep, goats, and swine from any state which has a herd or area quarantined for vesicular stomatitis shall:</u>

<u>004.12A</u> <u>Obtain a permit prior to import into Nebraska, with the permit number recorded on the CVI;</u>

004.12B Require the issuing veterinarian to record the following statement on the CVI: "The animals represented on this CVI have not originated from a premises or area under quarantine for vesicular stomatitis or a premises on which vesicular stomatitis has been diagnosed in the last thirty (30) days. I have examined the animals and found no signs of vesicular stomatitis"; and

<u>004.12C</u> For exhibition purposes, all animals imported into Nebraska shall be examined for vesicular stomatitis by an accredited veterinarian within forty-eight (48) hours of importation into Nebraska and so stated on the CVI.

<u>005 Importation of Cattle</u>. In addition to those general requirements contained in 23 NAC 2-004, the following requirements shall be met:

005.01 General Requirements.

<u>005.01A</u> All cattle requiring a permit for entry into Nebraska, as set forth in these regulations, shall have the permit number recorded on the CVI; and

<u>005.01B</u> All cattle requiring individual identification for entry into Nebraska, as set forth in these regulations, shall have the individual identification number recorded on the CVI; and

<u>005.01C</u> <u>005.01</u> Calves under two-hundred (200) pounds shall, be individually identified prior to entry, have individual identification, with metal official eartags identifying the herd of origin, meet the requirements in (1) subsection 005.02; , and (2) any individual disease identification or testing requirements pertaining to such calves as set forth in these regulations; and

<u>005.01C(1)</u> <u>005.01A</u> Originate from the farm or ranch where they were born and move directly to an approved livestock facility in Nebraska; or

005.01C(2) 005.01B They may be imported by state Nebraska residents, or their agents, provided that a permit for entry is first obtained and that the calves are moved move directly to the destination named on the permit to be held for a minimum of sixty (60) days.

005.02 Tuberculosis (TB).

<u>005.02A</u> Cattle entering Nebraska shall meet the general requirements set forth in 23 NAC 2-004 and 2-005.01 and this subsection;

<u>005.02B</u> Cattle being moved direct to slaughter at a federally recognized slaughter establishment may be imported without further restriction of this subsection;

<u>005.02C</u> Accredited Free State or Zone. Cattle which originate from a herd not under quarantine for TB in an accredited free state or zone may be imported into the state under the following conditions:

005.02A Cattle which originate from a herd not under quarantine for tuberculosis in an accredited-free state or zone, or country recognized by APHIS to be free of TB, or that are being moved direct to slaughter at a federally recognized slaughter establishment may be imported without further restriction of this subsection.

<u>005.02C(1)</u> Beef cattle and all neutered cattle of any age may be imported without further restriction of this subsection.

005.02C(2) Male and female dairy and dairy cross cattle shall have:

005.02C(2)(a) Individual identification;

005.02C(2)(b) A permit prior to entry into Nebraska; and

005.02C(2)(c) One of the following:

005.02C(2)(c)(i) If less than two (2) months of age:

005.02C2c(1)(a) Originate from an accredited herd; or

005.02C2c(1)(b) Be quarantined to their Nebraska destination, and test negative to an official tuberculin test within sixty (60) days after reaching two (2) months of age; or

005.02C2c(1)(c) Be quarantined to their Nebraska destination and neutered within sixty (60) days after reaching two (2) months of age; or

005.02C(2)(c)(ii) If two (2) months of age or older:

005.02C2c(2)(a) Originate from an accredited herd, with the accredited herd number recorded on the CVI; or

005.02C2c(2)(b) Be tested and found negative to an official tuberculin test after reaching two (2) months of age and within sixty (60) days prior to entry into Nebraska.

<u>005.02D</u> <u>005.02B</u> <u>Modified Accredited Advanced State or Zone.</u> Cattle which originate from a herd not under quarantine for <u>TB</u> <u>tuberculosis</u> in a modified accredited advanced state or zone may be imported into the state under the following conditions:

005.02D(1) 005.02B(1) Beef cattle and bison less than twelve (12) two (2) months of age and sexually altered neutered cattle of any age shall have: obtain a permit for entry.

005.02D(1)(a) A permit prior to entry into Nebraska; and

005.02D(1)(b) Individual identification.

<u>005.02D(2)</u> <u>005.02B(2)</u> All sexually intact beef Male and female beef cattle and bison twelve (12) two (2) months of age and older, shall have: obtain a permit for entry, be officially identified; and

005.02D(2)(a) A permit prior to entry into Nebraska; and

005.02D(2)(b) Individual identification; and

005.02D(2)(c) One of the following:

005.02D(2)(c)(i) 005.02B(2)(a) Originate Originate from an accredited herd, with the accredited herd number listed recorded on the Certificate of Veterinary Inspection CVI; or

005.02D(2)(c)(ii) 005.02B(2)(b) Originate Originate from a herd that has had a negative whole herd test within three hundred sixty-five (365) days prior to entry and the individual animals to be imported shall have been part of the whole herd test; or

005.02D(2)(c)(iii) 005.02B(2)(c) Shall have been Be individually tested and found negative to tuberculosis an official tuberculin test within sixty (60) days prior to entry.

005.02B(3) Dairy cattle under six (6) months of age shall have originated from a herd that has had a negative whole herd test within three hundred sixty-five (365) days, obtained a permit for entry prior to entry, have an official eartag, and shall be quarantined until testing negative for tuberculosis within sixty (60) days after reaching six (6) months of age.

005.02D(3) Male and female dairy and dairy cross cattle less than two (2) months of age shall have:

005.02D(3)(a) A permit prior to entry into Nebraska;

005.02D(3)(b) Individual identification; and

005.02D(3)(c) One of the following:

005.02D(3)(c)(i) Originate from an accredited herd with the accredited herd number recorded on the CVI; or

005.02D(3)(c)(ii) Originate from a herd that has had a negative whole herd test within three hundred sixty-five (365) days, and be quarantined to their Nebraska destination until tested and found negative to an official tuberculin test within sixty (60) days after reaching two (2) months of age; or

005.02D(3)(c)(iii) Be quarantined to their Nebraska destination and be neutered within one hundred twenty (120) days after reaching two (2) months of age.

<u>005.02B(4)</u> Dairy cattle six (6) months of age and older from an accredited herd shall have originated from a herd that has had a negative whole herd test within three hundred sixty-five (365) days, obtained a permit for entry prior to entry, have an official eartag, and individual animals shall be tested and found negative within sixty (60) days prior to entry if not included in the most recent whole herd test.

005.02D(4) Male and female dairy and dairy cross cattle, two (2) months of age and older, except as set forth in subpart 005.02D(5) below, shall have:

005.02D(4)(a) A permit prior to entry into Nebraska;

005.02D(4)(b) Individual identification; and

005.02D(4)(c) One of the following:

005.02D(4)(c)(i) Originate from an accredited herd with the accredited herd number recorded on the CVI; or

005.02D(4)(c)(ii) Be individually tested and found negative to an official tuberculin test within sixty (60) days prior to entry, except that no cattle shall be tested prior to two (2) months of age.

<u>005.02B(5)</u> Dairy cattle six (6) months of age and older from a non-accredited herd shall have originated from a herd that has had a negative whole herd test within three hundred sixty-five (365) days (assembled groups may qualify as a herd if all animals in the group from which the animals consigned to Nebraska are shipped from have been together for over ninety (90) days and have been tested and found negative for tuberculosis), obtained a permit for entry prior to entry, have an official eartag, and all individual animals shall be tested and found negative within sixty (60) days prior to entry.

<u>005.02D(5)</u> <u>Male and female dairy and dairy cross cattle, two (2) months</u> of age and older, from an assembled group shall have:

005.02D(5)(a) A permit prior to entry into Nebraska;

005.02D(5)(b) Individual identification; and

005.02D(5)(c) Two (2) negative official tuberculin tests as follows:

005.02D(5)(c)(i) The first negative tuberculin test shall not be conducted less than sixty (60) days nor more than one hundred twenty (120) days prior to entry into Nebraska; and

005.02D(5)(c)(ii) The second negative tuberculin test shall not be conducted less than sixty (60) days after the first test, nor more than sixty (60) days prior to entry into Nebraska.

<u>005.02E</u> <u>005.02C</u> <u>Modified Accredited State or Zone.</u> Cattle which originate from a herd not under quarantine for tuberculosis <u>TB</u> in a modified accredited state or zone may be imported under one of the following conditions:

<u>005.02E(1)</u> The cattle originate from an accredited herd and, shall; have:

005.02E(1)(a) 005.02C(1)(a) Have obtained a A permit for prior to entry into Nebraska; and

005.02E(1)(b) 005.02C(1)(b) Have listed their The accredited herd number recorded on the Certificate of Veterinary Inspection CVI; and

005.02E(1)(c) 005.02C(1)(c) Be individually identified with the identification listed on the Certificate of Veterinary Inspection Individual identification; and

005.02E(1)(d) One of the following:

005.02E(1)(d)(i) If less than two (2) months of age:

005.02E1d(1)(a) Be quarantined to their Nebraska destination and tested and found negative to an official tuberculin test within sixty (60) days after import into Nebraska, and after reaching two (2) months of age; or

005.02E(1)(d)(ii) If two (2) months of age and older:

005.02E1d(2)(a) Be tested and found negative to an official tuberculin test within sixty (60) days prior to entry, except that no cattle shall receive an official tuberculin test prior to two (2) months of age.

<u>005.02C(1)(d)</u> Have tested negative to an official tuberculin test within sixty (60) days prior to entry.

005.02E(2) 005.02C(2) The cattle originate from a herd, which has tested negative been tested and found negative to an official whole herd tuberculin test within three hundred sixty-five (365) days prior to entry, and shall have:

<u>005.02E(2)(a)</u> Have obtained a permit for entry; and A permit prior to entry into Nebraska;

005.02E(2)(b) Be individually identified with the identification listed on the Certificate of Veterinary Inspection; and Individual identification; and

005.02E(2)(c) One of the following:

005.02E(2)(c)(i) If less than two (2) months of age:

005.02E2c(1)(a) Be quarantined to their Nebraska destination and tested and found negative to an official tuberculin test after reaching two (2) months of age, and

005.02E2c(1)(b) Remain quarantined until a second test is completed within sixty to one hundred twenty (60 to 120) days after the first test; or

005.02E(2)(c)(ii) If two (2) months of age and older:

005.02E2c(2)(a) Be tested and found negative to an official tuberculin test within sixty (60) days prior to entry, except that no cattle shall be tested prior to two (2) months of age, and

005.02E2c(2)(b) Be quarantined to their Nebraska destination until tested and found negative to a second official tuberculin test within sixty to one hundred twenty (60 to 120) days after import.

<u>005.02C(2)(c)</u> Have tested negative to an official tuberculin test within sixty (60) days prior to entry; and

<u>005.02C(2)(d)</u> Be quarantined at destination until slaughtered or until tested negative to an official tuberculin test.

<u>005.02F</u> <u>005.02D</u> <u>Accreditation Preparatory State or Zone.</u> Cattle originating from an accreditation preparatory state or zone shall only be imported if they originate from an accredited herd, and shall have:

<u>005.02F(1)</u> <u>005.02D(1)</u> Obtain a permit for entry; A permit prior to entry into Nebraska;

<u>005.02F(2)</u> <u>005.02D(2)</u> Have their <u>The</u> accredited herd number listed recorded on the Certificate of Veterinary Inspection; CVI;

005.02F(3) 005.02D(3) Be individually identified, by means of a metal tag approved by USDA, APHIS, VS and the identification shall be listed on the Certificate of Veterinary Inspection; and Individual identification; and

005.02F(4) 005.02D(4) Test Tested negative to two (2) official tuberculin tests prior to entry. The first test shall have been conducted sixty to one hundred twenty (60 - 120) (60 to 120) days prior to entry and the second test zero to sixty (0 - 60) (0 to 60) days prior to entry. The test dates and results of such tests shall be recorded on the CVI.

005.02G 005.02E Cattle entering Nebraska from states or zones that are not accredited-free, excluding non-accredited states or zones, may move to an approved livestock facility in Nebraska only when such cattle are accompanied by documents which verify the animals have met the requirements as outlined above. Cattle consigned for sale to a Nebraska livestock auction market, which have not met TB testing requirements pursuant to 23 NAC 2-005 prior to entry, shall only be sold direct to slaughter.

<u>005.02H</u> <u>005.02F</u> <u>Nonaccredited State or Zone.</u> Cattle which originate from a herd in a nonaccredited state or zone are prohibited from being imported into the state of Nebraska, except when being moved directly to a federally recognized slaughter establishment.

005.03 Brucellosis.

<u>005.03A</u> The following cattle shall be allowed to enter the state with no further restrictions regarding brucellosis:

005.03A(1) Steers and spayed female Neutered cattle and bison; and or

<u>005.03A(2)</u> Cattle less than test-eligible age originating from a certified brucellosis-free herd, a Class Free state, a Class A state, or from a country recognized by APHIS as free of brucellosis. ; or

<u>005.03B</u> <u>005.03A(3)</u> Test-eligible cattle originating directly from a certified brucellosis-free herd, a Class Free state, or a country recognized by APHIS as free of brucellosis; and shall meet the following requirement:

005.03B(1) 005.03A(3)(a) Such cattle shall be identified with individual official identification and such individual official identification shall be recorded on the Certificate of Veterinary Inspection, or Such cattle imported for breeding purposes shall have individual identification.

<u>005.03A(3)(b)</u> A brand recorded in a brand registry The brand inspection certificate number shall be recorded on the Certificate of Veterinary Inspection and the brand inspection certificate shall accompany the shipment.

<u>005.03C</u> <u>005.03B</u> Test-eligible cattle originating from a Class A state shall meet the following requirements:

005.03C(1) 005.03B(1) Such cattle shall have be identified with individual official identification and such individual official identification shall be Certificate of Veterinary Inspection.; and

<u>005.03C(2)</u> <u>005.03B(2)</u> <u>Shall be Be</u> tested and found to be negative to an official <u>brucellosis</u> test for brucellosis within thirty (30) days prior to entry into Nebraska.

<u>005.04</u> <u>Trichomoniasis.</u> <u>Beef and dairy breeding cattle, except bison, imported for breeding purposes shall enter Nebraska with individual identification; and:</u>

005.04A Males:

005.04A(1) All males over twenty-four (24) months of age and all non-virgin males less than twenty-four (24) months of age shall have:

<u>005.04A(1)(a)</u> <u>Tested negative for trichomoniasis by a test or tests, approved by the Department, within thirty (30) days prior to importation;</u>

005.04A(1)(b) Samples submitted for testing which shall be collected by an accredited veterinarian trained to collect such samples, and conducted by a laboratory accredited by the American Association of Veterinary Laboratory Diagnosticians (AAVLD);

005.04A(1)(c) Not been used for breeding purposes for at least two (2) weeks prior to commencing trichomoniasis testing, nor shall there be any breeding activity from the time of the first test until after the males are imported into Nebraska; and

005.04A(2) A CVI signed by an accredited veterinarian shall state: "The breeding males represented on this CVI are not from a known positive *T. foetus* herd and have tested negative for trichomoniasis by a test or tests, approved by the Department, within thirty (30) days prior to importation"; and

<u>005.04A(3)</u> All males offered for sale at a Nebraska livestock auction market, imported for breeding purposes, shall meet the requirements of subparts 005.04A(1) through 005.04A(2) of this subsection prior to being offered for sale.

<u>005.04B</u> Exceptions to Trichomoniasis Testing Requirements For Males. The following males shall be exempt from the trichomoniasis testing requirements:

005.04B(1) Virgin males twenty-four (24) months of age or less. Such males shall be accompanied by a CVI containing a signed statement by an accredited veterinarian stating that the males have had no contact with breeding females.

005.04B(2) Males imported into Nebraska for slaughter purposes only, or those consigned directly to a licensed slaughter establishment, or to a licensed Nebraska livestock auction market and then directly to a licensed slaughter establishment.

005.04B(3) Males imported into Nebraska for a purpose other than breeding, such as males imported for exhibitions, rodeos, bull test stations, or to feedlots for feeding purposes and then direct to slaughter.

005.04B(4) Nebraska origin breeding males exported for seasonal grazing purposes may return to Nebraska without testing if accompanied by a CVI containing the following statement: "These breeding males have not commingled with any other herd." The CVI shall be issued within thirty (30) days prior to import into Nebraska.

005.04C Females.

005.04C(1) Female cattle originating from a known positive *T. foetus* herd shall not enter Nebraska unless they are consigned direct to slaughter.

005.04C(2) Except as set forth in subpart 005.04C(1), all females imported into Nebraska for breeding purposes, which are not consigned to an approved Nebraska livestock auction market, shall have one or more of the following statements recorded on the CVI and signed by an accredited veterinarian of the herd of origin:

<u>005.04C(2)(a)</u> "The females listed on this CVI are known virgins"; or

005.04C(2)(b) "Females listed on this CVI were exposed for their first breeding only to a known negative *T. foetus* male, or were artificially inseminated, and are not yet one hundred twenty (120) days pregnant"; or

005.04C(2)(c) "Females listed on this CVI are at least one hundred twenty (120) days pregnant"; or

005.04C(2)(d) "The females listed on this CVI did not originate from a known positive *T. foetus* herd, have a calf at side, and have not had any exposure to known positive *T. foetus* males or males of unknown *T. foetus* status since calving"; or

<u>005.04C(2)(e)</u> "The females listed on this CVI have had no exposure to other than known negative *T. foetus* males since parturition".

005.04C(3) Females, imported for breeding purposes and offered for sale at a Nebraska livestock auction market, shall be accompanied to their destination with an affidavit, attached as Appendix J, and is adopted and incorporated herein by reference, stating one of the conditions listed in divisions 005.04C(2)(a) through 005.04C(2)(e) above. The affidavit shall be signed by the owner or custodian of the cattle, the livestock auction market veterinarian, or both, prior to being offered for sale.

005.04D Exception to the Trichomoniasis statement requirements for females:

<u>005.04D(1)</u> Females moving direct to slaughter, or to a feedlot for feeding purposes and then to slaughter, are not subject to this subsection.

<u>005.04</u> Rodeo Bulls. Test-eligible rodeo bulls from a herd not known to be affected with brucellosis may move into Nebraska provided they have met the applicable requirements of subsection 005.02; and

<u>005.04A</u> The bull(s) are tested and found negative to an official brucellosis test conducted less than three hundred and sixty-five (365) days prior to entry; Provided, however, that the official brucellosis test is not required for a bull that is moved only between class free states; and

005.04B The bull(s) are identified with an official eartag; and

<u>005.04C</u> No change of ownership since the date of the last official brucellosis test; and

<u>005.04D</u> A Certificate of Veterinary Inspection accompanies the movement of the bull(s) into Nebraska; and

<u>005.04E</u> A permit has been issued within thirty (30) days prior to entry and the permit number is listed on the Certificate of Veterinary Inspection.

005.05 Rodeo Cattle. All rodeo cattle imported into Nebraska shall have:

005.05A A permit prior to entry into Nebraska;

005.05B Individual identification;

<u>005.05C</u> <u>Met all other requirements governing cattle importation set forth in</u> these regulations or by order or embargo issued by the Department; and

005.05C(1) Brucellosis Testing Requirements;

005.05C(1)(a) Test-eligible rodeo males from a herd not known to be affected with brucellosis may move into Nebraska provided they have met the applicable requirements of subsection 005.03; and

005.05C(1)(b) The CVI accompanies the movement of the males into Nebraska; and

005.05C(1)(c) The males are tested and found negative to an official brucellosis test conducted less than three hundred and sixty-five (365) days prior to entry; Provided, however, that the official brucellosis test is not required for a male that is moved only between class free states; and

005.05C(1)(d) No change of ownership since the date of the last official brucellosis test.

005.05C(2) TB Testing Requirements. All rodeo cattle two (2) months of age and older shall be tested and found negative to an official tuberculin test within six (6) months prior to import into Nebraska. The date of the official tuberculin test shall be recorded on the CVI.

<u>005.06</u> <u>005.05</u> Commuter and Grazing Permits. The <u>Bureau Department</u> may enter into written agreements with adjacent states setting forth conditions under which commuter and grazing permits may be issued. Movement of cattle for such purposes shall be in-accordance with 9 C.F.R. §78.9 (2003) compliance with federal regulations not inconsistent with the requirements set forth herein.

005.07 005.06 Cattle of Mexico origin shall meet the requirements in 23 NAC 2-011.

005.08 Cattle of Canada origin shall meet the requirements in 23 NAC 2-012.

<u>006 Importation of Swine</u>. In addition to those general requirements contained in 23 NAC 2-004, the following requirements shall be met:

006.01 General Requirements.

<u>006.01A</u> Wild pigs are prohibited from entering Nebraska pursuant to the Nebraska Administrative Code, Title 163, Chapter 4.

<u>006.01B</u> All swine changing ownership and moving to a destination in Nebraska shall move directly or through no more than one (1) concentration point, and shall be confined to the premises of destination for not less than thirty (30) days, unless moving <u>directly direct</u> to slaughter, or permission has been granted for other movement by the <u>Bureau Department</u>.

<u>006.01C</u> All swine imported for feeding or breeding shall have <u>official</u> <u>individual</u> identification <u>and with</u> the identification <u>number</u> <u>shall be</u> recorded on the <u>Certificate of Veterinary Inspection</u> CVI.

<u>006.02</u> Feeder Swine. <u>006.02A</u> Feeder swine imported into Nebraska shall originate from: <u>006.02A(1) A</u> a herd which is located in a state or area of a state which is classified as Stage IV or V, or a country recognized by APHIS as being free of pseudorabies ; or

<u>006.02A(2)</u> A qualified pseudorabies negative herd or qualified pseudorabies negative growout herd; or

<u>006.02A(3)</u> A herd in a Stage III area, not located within two (2) miles of a herd quarantined for pseudorabies, where a random sample test (95/10) of the breeding herd has been conducted within three hundred sixty-five (365) days prior to entry; or

<u>006.02A(4)</u> A herd in a Stage III area located within two (2) miles of a herd quarantined for pseudorabies, meeting the following requirements:

006.02A(4)(a) The premises have been negative to a random sample test (95/10) conducted within thirty (30) days prior to movement, and

006.02A(4)(b) Feeder swine thirteen (13) weeks and older have been vaccinated for pseudorabies at least ten (10) days prior to shipment, or feeder swine under thirteen (13) weeks of age originate from a sow herd which has been vaccinated for pseudorabies within the past six (6) months, and

006.02A(4)(c) An import quarantine shall be issued. The quarantine shall be released when the swine move to slaughter or a random sample test (95/10) of the shipment has been tested no sooner than thirty (30) days after arrival and found negative and the swine are in full compliance with the Animal Importation Regulations.

<u>006.02B</u> A permit for entry is required for all feeding swine originating from a state or area of a state which is not classified as Stage IV or V or from a country not recognized by APHIS as being free of pseudorabies.

006.03 Breeding Swine.

<u>006.03</u> <u>006.03A</u> Breeding swine imported into Nebraska shall meet the following requirements:

006.03A 006.03A(1) Brucellosis requirements. Swine over four (4) months of age shall be tested and found to be negative to an official brucellosis test within thirty (30) days prior to entry, or shall originate directly from: Breeding swine over four (4) months of age shall originate directly from a state or areas of a state classified as a validated brucellosis free state or from a country recognized by APHIS as being free of brucellosis as set forth in 9 C.F.R. §§78.40 to 78.43, which is attached as Appendix D, and in accordance with the Swine Brucellosis Control/Eradication, State-Federal-Industry Uniform Methods and Rules, Issued April 1998 which is attached as Appendix K, and is adopted and incorporated herein by reference.

006.03A(1) A validated brucellosis-free herd; or

006.03A(2) A herd in a validated brucellosis-free state; or

006.03A(3) A country recognized by APHIS to be free of brucellosis.

<u>006.03B</u> <u>006.03A(2)</u> Pseudorabies requirements. Swine originate directly from: Breeding swine shall originate directly from a state or area of a state classified as Stage IV or V, or a country recognized by APHIS as being free of pseudorabies.

006.03A(2)(a) A herd in a Stage III area that is testing monthly and is:

006.03A(2)(a)(i) A qualified pseudorabies negative herd; or

<u>006.03A(2)(a)(ii)</u> A qualified pseudorabies negative growout herd; or

<u>006.03A(2)(b)</u> A state or area of a state classified as Stage IV or V, or a country recognized by APHIS as being free of pseudorabies.

<u>006.03B</u> A permit for entry is required for all breeding swine originating from a state or area of a state which is not classified as Stage IV or V, or from a country not recognized by APHIS as being free of pseudorabies.

<u>006.03C</u> Swine imported for breeding purposes from a state or area of a state not classified as Stage IV or V or from a country not recognized by APHIS as being free of pseudorabies shall be isolated and quarantined and a random sample test (95/10) of the consignment conducted in not less than fifteen (15), nor more than forty-five (45) days after arrival in Nebraska, and

<u>006.03C(1)</u> If such swine are less than four (4) months of age, they shall be quarantined and a random sample test (95/10) conducted after they reach four (4) months, but before they reach six (6) months of age.

<u>006.03D</u> Swine semen imported into the state from herds not in Stage IV or V areas or states, shall originate from pseudorabies qualified negative herds.

<u>006.04</u> <u>006.03E</u> Swine from pseudorabies quarantined herds moving to Nebraska slaughter establishments shall move on a VS Form 1-27, and shall move direct to slaughter in <u>trucks</u> <u>conveyances</u> sealed by state or federal regulatory personnel or an accredited veterinarian. <u>and such Such truck conveyance</u> shall be cleaned and disinfected after unloading, but prior to transporting other animals.

006.05 006.04 Commuter Agreements. The Bureau Department may enter into written agreements with adjacent states setting forth conditions under which swine may move interstate within a swine production system in accordance with 9 C.F.R. §71.19(h) (2003).

<u>007 Importation of Sheep and Goats</u>. In addition to those general requirements contained in 23 NAC 2-004, the following requirements shall be met:

<u>007.01</u> Sheep and goats over six (6) months of age imported for breeding purposes shall obtain a permit for entry.

007.01A As of January 1, 2004, for any scrapie exposed sheep imported for breeding purposes, the results of an official genotype test shall be included on, or attached to, the permit and shall be QR or RR at codon 171.

<u>007.02</u> All sheep and goats imported into the State of Nebraska shall be individually identified according to the requirements of Scrapie Eradication Program 9 C.F.R. §79.2 (2003) with the official identification recorded on the Certificate of Veterinary Inspection.

<u>007.03</u> As of January 1, 2004, scrapie-positive animals, scrapie suspect animals, and sheep or goats from any noncompliant flock are prohibited from being imported into the State of Nebraska.

007.04 As of January 1, 2004, sexually intact animals at high-risk for scrapie and non-high-risk animals from an infected or source flock require a permit for entry and are only allowed to be imported into the State of Nebraska if they are being sold direct to slaughter, through slaughter channels to slaughter, or to feedlots for later movement to slaughter.

<u>007.05</u> As of January 1, 2004, pregnant animals and animals with a visible vaginal discharge that are scrapie exposed, or considered high-risk, require a permit for entry and may only be imported direct to slaughter.

007.01 Sheep.

007.01A Sheep imported for breeding purposes, except scrapie exposed sheep, shall obtain a permit for entry. Scrapie exposed sheep imported for breeding purposes shall include the results of an official genotype test on, or attached to, the permit, and shall be QR or RR at codon 171;

007.01B Sheep imported into Nebraska shall have official identification, as such identification is defined in 9 C.F.R. §§ 79.1 and 79.2(a)(2), and attached as Appendix D, as required pursuant to the Scrapie Eradication Program. The official identification number shall be recorded on the CVI;

007.01C Scrapie-positive sheep, scrapie suspect sheep, and sheep from any noncompliant flock, as such terms are defined in 9 C.F.R. §§ 79.1 and 79.2, are prohibited from being imported into Nebraska;

007.01D Female sheep at high-risk for scrapie and non-high-risk sheep from an infected or source flock require a permit for entry and are only allowed to be imported into Nebraska if they are being sold direct to slaughter, through slaughter channels to slaughter, or to feedlots for later movement to slaughter; and

<u>007.01E</u> <u>Pregnant sheep and sheep with a visible vaginal discharge that are scrapie exposed, or considered high-risk, require a permit for entry and may only be imported direct to slaughter.</u>

007.02 Goats.

<u>007.02A</u> All goats imported into Nebraska for breeding purposes shall obtain a permit for entry;

007.02B All goats imported into Nebraska shall have official identification, as such identification is defined in 9 C.F.R. §§ 79.1 and 79.2(a)(2), as required pursuant to the Scrapie Eradication Program. The official identification number shall be recorded on the CVI;

007.02C Scrapie-positive goats, scrapie suspect goats, and goats from any noncompliant flock, as such terms are defined in 9 C.F.R. §§ 79.1 and 79.2, are prohibited from being imported into Nebraska;

007.02D Goats at high-risk for scrapie and non-high-risk goats from an infected or source flock require a permit for entry and are only allowed to be imported into Nebraska if they are being sold direct to slaughter, through slaughter channels to slaughter, or to feedlots for later movement to slaughter; and

007.02E All dairy goats less than two (2) months of age shall be quarantined to their Nebraska destination and tested negative to an official tuberculin test within sixty (60) days after reaching two (2) months of age. Such goats shall remain at their Nebraska destination and not be removed from this premises without the approval of the Department; or

007.02F All dairy goats two (2) months of age and older shall be tested and found negative to an official tuberculin test after reaching two (2) months of age and within sixty (60) days prior to entry into Nebraska.

<u>008 Importation of Equidae</u>. In addition to those general requirements contained in 23 NAC 2-004, the following requirements shall be met:

<u>008.01</u> Equidae shall be accompanied by a Certificate of Veterinary Inspection <u>CVI</u> which certifies that such equidae, originating from states other than South Dakota, have been tested and found negative for Equine Infectious Anemia (EIA) within one (1) year of

shipment into the State of Nebraska, except that foals under six (6) months of age accompanying their dam shall be exempt from this requirement. The name of the laboratory performing the EIA test and date of such test shall be stated on the Certificate of Veterinary Inspection; CVI. or

<u>008.02</u> Horses going directly to a federally recognized slaughter establishment or through an approved livestock facility to a federally recognized slaughter establishment shall be exempt from the Equine Infectious Anemia (EIA) testing requirement.

<u>009 Importation of Dogs and Cats</u>. In addition to those general requirements contained in 23 NAC 2-004, the following requirements shall be met:

<u>009.01</u> All dogs and cats entering the state shall be accompanied by a Certificate of Veterinary Inspection <u>CVI</u> which certifies such dog or cat is currently immunized against rabies; or

<u>009.02</u> Dogs and cats, over three (3) months of age, not vaccinated for rabies <u>at the time of import imported</u> into the state shall be vaccinated against rabies within thirty (30) days after arrival, in accordance with <u>Neb</u>. <u>Rev</u>. <u>Stat</u>. §§71-4401 to 71-4412 and the rules and regulations adopted and promulgated thereunder by the Nebraska Department of Health and Human Services. All inquiries concerning rabies vaccination should be made to the Department of Health and Human Services which is located in the State Office Building, Third Floor, 301 Centennial Mall South, Lincoln, Nebraska 68509. The telephone number is (402) 471-2133.

<u>010 Importation of Poultry and Ratite Birds.</u> In addition to those general requirements contained in 23 NAC 2-004, the importation requirements for poultry and ratite birds to control and eradicate hatchery-disseminated diseases shall be as prescribed by the Nebraska Poultry Disease Control Act, <u>Neb</u>. <u>Rev</u>. <u>Stat.</u> §§2-3001 to 2-3008, and 23 NAC 9, adopted thereunder, and the following:

010.01 Poultry and ratite birds under eight (8) weeks of age shall:

010.01A Be accompanied by a VS Form 9-3;

<u>010.01B</u> Obtain a pre-assigned <u>out of state poultry permit, Permit to Ship Poultry and/or Hatching Eggs into Nebraska <u>Out-of-State Poultry Permit, a copy of which is attached as Appendix L, and is adopted and incorporated herein by reference; and</u></u>

<u>010.01C</u> Originate from an National Poultry Improvement Plan (NPIP) participating flock or hatchery, or flock with equivalent status, pursuant to 9 C.F.R. <u>parts</u> 145 to 147.

010.02 Poultry and ratite birds over eight (8) weeks of age shall:

010.02A Be accompanied by a Certificate of Veterinary Inspection CVI;

010.02B Obtain a permit for entry; and

<u>010.02C</u> Originate from an NPIP participating flock or be individually tested and found to be negative for pullorum and typhoid within <u>ninety (90)</u> 90 days of <u>prior</u> <u>to</u> importation.

<u>011 Importation of Mexico Origin Cattle.</u> In addition to those general requirements contained in 23 NAC 2-004 <u>and 23 NAC 2-005.04</u>, cattle which have lived any part of their lives in Mexico may enter the state provided they are accompanied by a Certificate of Veterinary Inspection CVI and the following requirements are met:

<u>011.01</u> All such cattle have entered the United States by meeting the pertinent requirements of 9 C.F.R. §§93.424 through 93.427, and 93.429 (2003) a copy of which is attached as Appendix D, and is adopted and incorporated herein by reference; and

<u>011.02</u> A permit for entry shall be obtained for such cattle except for cattle moving direct to slaughter; and

O11.03 All such cattle are individually identified by a USDA official eartag identification device or method as defined in 9 C.F.R. §93.400, a copy of which is attached as Appendix D, and is adopted and incorporated herein by reference or an official eartag issued by the Mexican Ministry of Agriculture and Water Resources (SARH) Ministry of Agriculture, Livestock, Rural Development, Fisheries and Food (SAGARPA). The individual official identification shall be recorded on the Certificate of Veterinary Inspection CVI.

011.04 Brucellosis requirements (except steers and spayed female neutered cattle).

<u>011.04A</u> All female cattle over four (4) months of age, shall be officially calfhood vaccinated; and

<u>011.04A(1)</u> All cattle which are test-eligible age shall be tested and found to be negative to an official brucellosis test conducted within thirty (30) days prior to entry into Nebraska and remain at the Nebraska destination under quarantine until they are subjected to an official brucellosis test conducted at least sixty (60) but not more than one hundred and and twenty (120) days after entry into Nebraska.

<u>011.04A(2)</u> All cattle which are less than test-eligible age, may enter Nebraska provided such cattle remain at the destination in Nebraska under quarantine until they are moved to slaughter, or become test-eligible age and are subjected to an official brucellosis test conducted within one hundred and and twenty (120) days after reaching test-eligible age.

011.05 Tuberculosis (TB) requirements.

011.05A All cattle shall be subjected to an official tuberculin test and found to be

negative within sixty (60) days prior to entry into Nebraska. Such cattle shall remain at the Nebraska destination under quarantine until they have been subjected to an official tuberculin test conducted at least sixty (60) days after the date of the importation tuberculin test, but not more than one hundred and twenty (120) days after entry into Nebraska; except

O11.05B Steers and spayed female Neutered cattle may move to a feedlot in Nebraska where adequate separation is maintained to prevent contact with animals being fed for purposes other than slaughter. Such cattle will be placed under an import a quarantine until moved to slaughter. The person responsible for the cattle, shall notify the Bureau Department when, and where the cattle are slaughtered; except:

<u>011.05B(1)</u> Steers and spayed female <u>Neutered</u> cattle which have been tested and found negative to an official tuberculin test conducted at least sixty (60) days after the date of the importation test, import into the <u>United States</u>, may move into Nebraska for grazing or feeding with no further restrictions regarding <u>TB</u> tuberculosis.

<u>011.06</u> In lieu of a retest for brucellosis and tuberculosis listed <u>TB as required</u> above, the owner may sign a statement that the cattle will be slaughtered within one hundred eighty (180) days of entry into the state. The owner shall notify the <u>Bureau Department</u> when and where the cattle are slaughtered to release the quarantine.

012 Importation of Canada Origin Cattle. In addition to those general requirements contained in 23 NAC 2-004 and 23 NAC 2-005 herein, cattle which have lived any part of their lives in Canada may enter the state provided they are accompanied by a CVI and the following requirements are met:

012.01 All such cattle have entered the United States by meeting the pertinent requirements of 9 C.F.R. §§93.417 through 93.418, and 93.420;

012.02 Were born on or after March 1, 1999; and

O12.03 Are individually identified with either an official Canadian Food Inspection Agency (CFIA) RFID tag or an official identification device or method as defined in 9 C.F.R. §93.400, a copy of which is attached as Appendix D, and is adopted and incorporated herein by reference, and the identification number shall be recorded on the CVI; and

012.04 Are imported for the purpose of immediate slaughter; or

<u>012.05</u> <u>If not imported for the purpose of immediate slaughter, shall meet the following requirements:</u>

<u>012.05A</u> A permit shall be obtained prior to entry, with the permit number recorded on the CVI; and

<u>012.05B</u> <u>Purebred registered bovine animals may be imported with ear tattoos, provided the following requirements are met:</u>

012.05B(1) All tattoos shall be legible; and

012.05B(2) All tattoos shall be official breed registration tattoos; and

<u>012.05B(3)</u> All animals identified with a breed registration tattoo shall also be identified with a "CAN" tattoo applied to the inside of the left ear; or

<u>012.05C</u> <u>Non-registered cattle shall be properly hot iron or freeze branded with a "CAN" brand, high on the right hip prior to entry. Hairbrands are not acceptable.</u>

<u>013</u> <u>012</u> <u>Importation of Cervidae</u>. In addition to those general requirements contained in 23 NAC 2-004 herein, the following requirements shall be met:

<u>013.01</u> <u>012.01</u> Cervidae (with the exception of white-tail deer, mule deer, and red deer, or any of their hybrids) may enter the state when they are accompanied by a Certificate of Veterinary Inspection <u>CVI</u>; and

<u>013.01A</u> <u>012.01A</u> A permit for entry is issued by the <u>Bureau Department</u> to a premises with a valid Domesticated Cervine Animal Permit issued by the Department; and

<u>013.01B</u> <u>012.01B</u> The cervidae shall be individually identified by both permanent individual identification and visible individual identification and all identification numbers shall be recorded on the Certificate of Veterinary Inspection <u>CVI</u>; and

<u>013.01C</u> <u>012.01C</u> Cervidae less than six (6) months of age that accompany their dam will be subject to the same retest requirements as their dam, but will not require any brucellosis or tuberculosis <u>TB</u> testing prior to importation into Nebraska; and

013.01D 012.01D Cervidae less than six (6) months of age that do not accompany their dam will be subject to an official cervidae test for brucellosis and tuberculosis TB in not less than one hundred and twenty (120) days, but not more than three hundred and sixty-five (365) days after importation into in Nebraska; and

<u>013.01E</u> Oervidae imported into Nebraska shall have moved through no more than one concentration point within the previous ninety (90) days.

013.02 012.02 Chronic Wasting Disease (CWD) Requirements.

<u>013.02A</u> <u>012.02A</u> No elk shall be allowed to be imported into Nebraska from any province in Canada that has had a confirmed CWD-positive animal, or from an area that has been determined to be a CWD-endemic area in the United States, or from a cervid herd that is quarantined for any purpose, or has been determined to be exposed to CWD within the past sixty (60) months.

O13.02B O12.02B Cervids to be imported into the state shall originate from a herd which has participated for, at least, sixty (60) months in a Chronic Wasting Disease (CWD) Monitoring Program which is determined by the Bureau Department to be equivalent to the Nebraska CWD-Monitoring Program Guidelines for Nebraska Chronic Wasting Disease Cervid Monitoring Program and Cervid Risk Assessment forms, (IMP15, IMP16, IMP17, and State of Origin of Non-Indigenous Cervids), a copy of which is attached and incorporated herein as Appendix M, and is adopted and incorporated herein by reference.

o13.02B(1) o12.02B(1) Cervids that are going to a cervid hunt pasture shall originate from a herd that has participated in a CWD Monitoring Program for at least thirty-six (36) months. Cervids imported into Nebraska with a thirty-six (36) month CWD status shall be harvested within the following twelve (12) months.

O13.02C O12.02C No cervid animal(s) animals of a species indigenous to Nebraska shall be allowed to be imported into the state without the Nebraska Cervid Risk Assessment Forms, provided by the Bureau Department, accompanying the Certificate of Veterinary Inspection CVI. The forms shall include a statement signed by the owner or seller stating that the herd of origin has had no diagnoses of CWD for the past sixty (60) months, or thirty-six (36) months for cervids moving to a cervid hunt pasture, the herd has been enrolled in a CWD-Monitoring Program for at least sixty (60) months, or thirty-six (36) months for cervids moving to a cervid hunt pasture, and the purpose for movement. The individual receiving cervids from a facility with a thirty-six (36) month status shall sign an agreement to harvest the animals in 12 months. The owner shall also include a herd addition form, a death loss report, an inventory of imported animals, and a list of all previous and current veterinarians, all of which are included in the Nebraska Cervid Risk Assessment Forms.

013.02D 012.02D Non-indigenous cervid animal(s) animals shall not be allowed to be imported into Nebraska without a form, provided by the Bureau Department, accompanying the Certificate of Veterinary Inspection CVI containing a statement signed by the owner or seller certifying the animal(s) animals has have not spent any time within the past thirty-six (36) months in a zoo, animal menagerie, or like animals facility, and has have not resided on the

same premises as a cervid herd which has have been classified as a CWD-infected herd, CWD-exposed herd, or a CWD-trace herd, and has have not resided in any area determined to be an CWD-endemic area. The owner shall also include a herd addition form and an inventory of imported animals.

<u>013.02E</u> <u>012.02E</u> Cervids being granted entry into the state are required to be held separate and apart from other cervids until inspected by a <u>Bureau</u> <u>Department</u> veterinarian or livestock inspector.

 $\underline{013.03}$ $\underline{012.03}$ Brucellosis requirements for cervidae other than $\underline{012.01C}$ parts $\underline{013.01C}$ and $\underline{012.01D}$ 013.01D above.

<u>013.03A</u> <u>012.03A</u> Cervidae six (6) months of age and older shall be tested and found to be negative by an official brucellosis test for cervidae conducted within ninety (90) days prior to entry, or originate directly from a certified brucellosis free herd.

<u>013.04</u> <u>012.04</u> <u>Tuberculosis</u> <u>TB</u> requirements for cervidae other than <u>parts 013.01C</u> 012.01C and 013.01D 012.01D above.

<u>013.04A</u> <u>012.04A</u> Cervidae of any age imported into Nebraska directly from a tuberculosis <u>TB</u> accredited herd do not require tuberculosis <u>TB</u> testing prior to or after arrival in Nebraska; or

013.04B 012.04B Cervidae over six (6) months of age imported into Nebraska directly from a tuberculosis TB qualified or monitored herd shall be tested and found to be negative by an official tuberculin test for cervidae within ninety (90) days prior to entry into the state; or

013.04C 012.04C Cervidae over six (6) months of age imported into Nebraska directly from a herd which is not tuberculosis TB monitored, qualified, or accredited shall be segregated from other animals and subjected to two (2) official tuberculosis tuberculin tests for cervidae and found to be negative. Such tests shall be at least ninety (90) days, but not more than three hundred and sixty-five (365) days apart with the last test being within ninety (90) days prior to entry into the state.

<u>014</u> <u>013</u> Importation of Exotic Animals. In addition to those general requirements contained in 23 NAC 2-004, the following requirements shall be met:

<u>014.01</u> <u>013.01</u> A permit for entry shall be obtained from the <u>Bureau Department</u> prior to each shipment; and

014.02 013.02 The following species shall meet the additional requirements:

<u>014.02A</u> <u>013.02A</u> <u>Camels Camelids, including but not limited to camels, Ilamas and alpacas, over six (6) months of age shall be tested and found to be negative for brucellosis and tuberculosis <u>TB</u> within sixty (60) days prior to entry into the state.</u>

<u>014.02B</u> <u>913.02B</u> <u>Yaks</u> <u>Bovids, except cattle and bison, over six (6) months of age shall be tested and found to be negative for brucellosis and tuberculosis <u>TB</u> within sixty (60) days prior to entry into the state.</u>

<u>014.02C</u> <u>O13.02C</u> <u>Zebras</u> <u>Equids</u> shall comply with <u>section 008</u> <u>23 NAC 2-008</u> prior to entry into the state.

<u>014.02D</u> <u>013.02D</u> Psittacine birds shall be found to be free of signs of psittacosis for sixty (60) days prior to entry into the state.

<u>014.03</u> <u>013.03</u> In addition to the above requirements, these animals shall meet <u>These</u> regulations do not preclude these animals from meeting any requirements of the United States Fish and Wildlife Service and the Nebraska Game and Parks Commission. Game and Parks Commission regulations provide that it shall be unlawful to import into the state Asian raccoon dogs, white-tail deer, mule deer, and red deer or any of its hybrids, and wild pigs: , and any other wildlife species identified as unlawful in the state by the Game and Parks Commission. (See Title 163, Chapter 4, Nebraska Game and Parks Commission - Wildlife Regulations, Keeping Wildlife in Captivity, 008.07 Restricted Species.)
